During year 2009-10, there is a provision for financial assistance to children with special needs studying in classes IX to XII (including VHSE). As per ref (ii) cited, MHRD has sanctioned fund for financial assistance to children with special needs.

As such, Rs.5,25,29,600/- (Rupees five crores twenty five lakhs twenty nine thousand six hundred only) has sanctioned to the DEOs, Regional Deputy Directors (HSE) and Assistance Directors (VHSE) for disbursing among financial assistance to CWSN in High School, Higher Secondary and VHSE classes.

Additional fund requirement has received from the above offices and sanction is hereby accorded for the release of Rs.1,32,25,400/- (Rupees one crore thirty two lakhs twenty five thousand and four hundred only) for the disbursement of financial assistance to CWSN for the year 2009-10 which is to be debited to the Head of Account 2235-02-101-95-34 OC (Plan).

Budget section of this Directorate may place an amount of Rs.1,32,25,400/- (Rupees one crore thirty two lakhs twenty five thousand and four hundred only) under the Head of Account 2235-02-101-95-34-OC (Plan) for disbursement among the Deputy Directors of Education, Regional Deputy Directors (HSE) and Assistant Directors (VHSE) as per the break-up given below.

Deputy Directors may re-allot the amount as per the break-up given to the DEOs who may in turn draw and disburse the amount to the schools concerned and the Head Masters should disburse the amount to the students with proper acquittance on or before 31/3/2010.

The Regional Deputy Directors (HSE) and Assistant Directors (VHSE) may re-allot the fund to the Principals (HSS) and Head Masters (VHSS) and the same should be disbursed to the students with proper acquittance on or before 31/03/2010.
