Under the IEDSS scheme, there is a provision for Hostel Allowance to Children with Special Needs who are staying in Hostels. Based on the proposal submitted by State Government, MHRD, as per ref (iv), have sanctioned fund for this item.

As per ref (iii), sub-offices have furnished the list of students eligible for Hostel Allowance. Hence sanction is hereby accorded for the release of Rs.4,04,625/- (Rupees four lakhs four thousand six hundred and twenty five only) for the year 2009-10, as per the break-up given below:

The expenditure will be debited to the Head of Account 2235-02-101-95-34 OC (Plan). Budget section of this Directorate is requested to place an amount of Rs.4,04,625/- (Rupees four lakhs four thousand six hundred and twenty five only) at the disposal of RDD Thiruvananthapuram and Deputy Directors of Education concerned. RDD, Thiruvananthapuram may draw the fund from treasury and disburse it to the Principals of the HSS concerned to disburse to the students. DDEs concerned will re-allot the fund to the DEOs concerned who in turn draw and disburse the amount to the Head Masters of the schools for disbursement to the beneficiaries.
